EPS PURPOSE

 Coordination of state and local law enforcement activities to ensure the protection of life and property during all emergency situations by providing a comprehensive program (EPS SOP) of emergency procedures, leadership, (Area and State Staff) and staffing (EPS Resources), provide equipment (MCC, light tower, radio cache) and mobilization of resources (ALERT) for both pre and post event activities.



EPS

- EPS is a state-wide mutual aid response at the request of a law enforcement agency in need.
- EPS responds upon exhaustion of local mutual aid – You call we coordinate!!
- EPS is your Liaison to Federal LE via FEMA Region V
- EPS is your reach back to state LE resources
 - DOC, DOA, WSP, DNR, and UW-Police



EPS

- EPS leadership coordinates the response
 - State level staff Advisory
 - Corrections Secretary
 - Admin WSP
 - UW-Madison Police Chief
 - Capitol Police Chief
 - Chief DNR Warden
 - DOJ/DCI
 - WI Ntl Guard
 - Regional Directors and alternates
 - Primary Sheriff and an alternate
 - Police Chief
 - WSP District Captain
 - Lead DNR Warden

Key Players





EPS is a Partnership with Sheriffs and Chief's of Police + State Agencies

- Keys to EPS Success
 - State agency Partners
 - Regional EPS Staff
 - Sheriffs and Chiefs talking, coordinating and facilitating
 - Pre-planned events Include EPS in planning early
 - Emergencies early recognition of the need for EPS

EPS – Your role

- Each Sheriff is the EPS Director for the county and appoints a police administrator from within the county as a Deputy Director.
- Every Police Chief is EPS Coordinator for their own village, Town, or City



EPS ASSUMPTIONS

- EPS is mutual aid on steroids
- Reimbursement always an issue
- You will provide the resources you can when requested
- You will receive resources you need when requested
- You are more likely to support EPS than request EPS resources
- Sheriffs vs. Chiefs

EPS Capabilities

- EPS can access over 12k LE officers and deputies
- Access to specialized personnel and equipment
- Mobile Communications Center
- Mobile light Tower
- Mobile Repeaters
- Radio Cache
- Generator trailer
- Access to everything you need others have

EPS ORGANIZATION

 Area Director elected by LE officials from the area. (Four-year term)

 Area Director appoints one Sheriff and one Police Chief as area Alternate/Deputy Director.



The EPS Activation Process

- Upon determination local resources and normal mutual aid partners will be or are exhausted, the impacted Chief or Sheriff would contact either the WEM Duty Officer or the EPS Area Director.
 - Requestor would determine number or officers/deputies needed, the mission, & for how long.
 - Requestor would determine "report" time and place.
- EPS has great capacity, personnel & equipment.
- EPS can be used for planned and emergent events.

Control & Authority comes with Responsibility

- Initiating county/city sheriff/chief maintains the command and control.
- Requesting agency is responsible for the cost of the operation.
- However, in some cases the state and or the federal government has reimbursed the local governments in the events such as flooding, tornadoes, and BRB security.





ALERT Mission

Primary:

Deliver enhanced tactical capability through specialized/critical equipment, advanced tactics and a highly coordinated response plan when activated as a statewide asset.

Secondary:

Make available specialized/critical equipment and/or advanced tactics through mutual aid requests for incidents that do not meet the activation threshold.

Why develop regional teams?

To acquire critical equipment and enhanced tactical capability that protects us from terrorist acts

To establish a coordinated response to catastrophic events that would otherwise overwhelm local resources



What is the role of the law enforcement teams?

Support local resources if/when requested through Mutual Aid
